#### **ROBIN MAHER**

#### 2022 OUTSTANDING SERVICE AWARD WINNERS

#### Raelene Caswell

Standpoint

#### Advocate Award

Raelene Caswell (she/her) began her work as an advocate in 2009, and currently serves as the housing advocate with Standpoint. In this role, she works alongside the housing attorney to assist tenants who are victim/survivors of domestic and sexual violence in navigating housing issues, including breaking a lease due to fear of violence, asserting Violence Against Women Act housing protections, and communicating with landlords, as well as providing training to advocates across the state. With the team of advocates, Raelene also provides legal advocacy through Standpoint's Action Line on housing, Orders for Protection and Restraining orders, and other safety-related concerns.

Raelene also enjoys providing supervision and mentorship for Standpoint's general interns, helping them learn about the role of the advocate within the legal system. She also works with the Alexandra House, responds to victim/survivors in the hospital, and provides support on the crisis line and shelter-based advocacy, often including housing support.

Raelene has worked with several agencies, including the Sexual Violence Center, Cornerstone, Women's Advocates, SafeJourney, Catholic Charities, and Freedom House to provide dignified services to those seeking safety. This work includes housing stabilization, crisis intervention, shelter-based advocacy, crisis line supports, hospital-based advocacy, and program development.

In addition, Raelene is particularly passionate about preventing burnout and promoting the wellness and resiliency of advocates in the field. She received her bachelor's in Gender, Women, and Sexuality Studies and History from Gustavus Adolphus College, and holds a Masters in Advocacy and Political Leadership from Metropolitan State. In her free time, Raelene enjoys reading, Irish dancing and ballet, and spending time with her friends, family, and cat.

#### **Bradford Colbert**

Mitchell Hamline School of Law

#### **Direct Legal Service Award**

Bradford Colbert is the Director of the Legal Assistance to Minnesota Prisoners (LAMP) Clinic at Mitchell Hamline School of Law. The LAMP Clinic represents people who are incarcerated on civil legal issues. LAMP cases range from default dissolutions to complicated class actions. In addition to directing the LAMP Clinic, Professor Colbert teaches Criminal Law and Constitutional Criminal Procedure at the law school. Professor Colbert is a former appellate public defender; in that role, he argued Minnesota v. Carter before the United States Supreme Court (and lost). Professor Colbert has been awarded the William E. McGee Public Defender Award of Excellence and the Minnesota Lawyer Attorney of the Year.

#### Kurt W. Porter

Severson Porter Law

#### **Private Practice Lawyer Award**

Kurt W. Porter is an attorney and partner with Severson Porter Law. Admitted to the Minnesota Bar in 2010, he focuses his practice on Real Estate, Business Law and Civil Litigation. Kurt is a Certified Real Estate Specialist; fewer than 3% of all registered attorneys in the State of Minnesota are certified specialists in their respective fields. He is a regular presenter for Minnesota CLE on issues related to real estate law, most recently focusing on the developing law relating to short term rentals. Kurt frequently provides pro bono services on matters concerning real estate law.

Kurt obtained his Bachelors of Science degree in mathematics, with minor degrees in statistics and English from the University of North Dakota. Thereafter, Kurt attended law school at the University of North Dakota School of Law where he earned his Juris Doctorate with distinction. After law school, Kurt worked as a law clerk for the Honorable Erik J. Askegaard, District Court Judge for the Ninth Judicial District.

Kurt serves on various organizations in the Brainerd Lakes Area, including Lakes Area Restorative Justice Project, Coordinating Council for Domestic Violence, and presently serves as the Secretary-Treasurer for the Crow Wing County/Aitkin County Bar Association and as Church

#### **Marilys Solano**

#### Law Student Award Winner

Marilys Solano is a first-generation Latina, born and raised in Miami, Florida. Her parents are both from Nicaragua. She completed her undergraduate degree at Florida International University and double-majored in International Business and Management. She is a third-year, blended learning student at Mitchell Hamline School of Law. This year she is the Student Body Association's (SBA) Treasurer and the Vice President for the Latine Law Student Association (LLSA). Since May 2022, she has been working part-time as a Research Assistant with Professor Jill Bryant and Research Librarian Alisha Hennan as they follow the progeny of the corporate entities that profited from industrial slavery (or peonage).

During her undergraduate years Marilys explored different philanthropic opportunities, but none resonated with her as much as being a guardian ad litem (GAL). A wonderful mentor knew how fond she was (and still is) of children and suggested she research the local GAL program. A guardian ad litem is a court-appointed representative who protects a child's best interests. They conduct monthly visitations and reports, attend court hearings, provide testimony, and participate in any other conference pertaining to the child. More importantly, they communicate and interact with the children and all the parties involved. A year later, Marilys has learned, grown, and seen the impact her service provides for the children and their families.

Currently, she lives with her husband and dog in Grenada, where her husband attends medical school. Since their move, she learned that her opportunities as a GAL can continue through virtual case opportunities. Being a GAL has been one of the most rewarding experiences she has ever been a part of, and she is excited to continue impacting her community for the children.

#### Madelyn Cox-Guerra

#### Law Student Award Winner

Madelyn Cox-Guerra (class of 2023) is a dedicated public interest advocate. Madelyn has a deep commitment to working for juvenile justice, with a special interest in advocating for noncitizen juveniles in the criminal justice system. She has clerked with the Irish Legal Aid Board, the Minnesota 4th Judicial District Family Court, the Housing Justice Center, the National Center for Youth Law, and is a student attorney director with the University of Minnesota's Detainee Rights Clinic. Throughout law school, Madelyn has volunteered with HOME Line, the National Lawyers Guild, and the Anoka County Public Defender's Office. Madelyn also demonstrates her commitment to justice by serving in leadership positions in several student organizations, including the Minnesota Justice Foundation, the Latinx Law Students Association, and the Journal of Law & Inequality. Madelyn is grateful and honored to receive the 2022 Outstanding Service Award.

#### **Kevin Green**

#### Law Student Award Winner

Kevin Green is a 3L student at the University of St. Thomas School of Law, where he has been actively engaged in student leadership and scholarship. Kevin is the Student Body President and this year he has initiated the law school's first ever LLM/JD Welcome Dinner to honor the contributions of the LLM class. He is also an Associate Editor on the school's Journal of Law and Public Policy. As with many first-generation law school students, Kevin did not know what area of practice he wanted to pursue, but he took advantage of every opportunity St. Thomas had to offer to answer that question. He has externed with the Honorable Judge JaPaul Harris of Ramsey County, during his 1L year he worked as a Law Clerk with the Hennepin County Attorney Office, and he has externed with the Wright County Public Defender's Office through his course work with Shawn Webb's Misdemeanor Defense Externship at St. Thomas. Furthermore, Kevin spent his 1L and 2L summers as a Summer Associate

#### Marra Clay

Marra Clay is a 2022 magna cum laude graduate of the University of Minnesota Law School, where she received Intellectual Property & Technology Law concentration honors and served as the Lead Note & Comment Editor of Minnesota Law Review. Marra spent her 2L summer as a summer associate at Merchant & Gould P.C., where she had the opportunity to work on several pro bono cases. She represented an immigration client in a hearing before the Immigration Court. Marra found this experience influential, and is highly committed to continuing her pro bono immigration practice throughout her legal career. Additionally, Marra served as a member of the executive board for If/When/How: Lawyering for Reproductive Justice throughout law school. She also volunteered as a Girl Scout Troop Leader in South Minneapolis to create community in her neighborhood during the COVID-19 pandemic. Prior to law school, Marra served as a Fulbright English Teaching Assistant in Malaysia, where she held weekly Englishspeaking workshops and received U.S. Embassy Grants to fund school sustainability projects. Marra is a 2017 graduate of Whitman College, where she studied Chemistry and Environmental Studies and was the publisher of the student newspaper. During college, she volunteered with Science Outreach, Classroom Connections, and the Mentor Program to increase STEM education access in public schools. In 2010, she received the President's Volunteer Service Award. Marra is currently a judicial clerk for the Honorable John R. Tunheim at the U.S. District Court for the District of Minnesota.

#### Yemaya Hanna

Yemaya Hanna has been an exceptional role model for other law students and attorneys through her early and enduring commitment to pro bono and volunteer service. As a law student at the University of Minnesota, she brought skilled leadership and compassion to her many roles. Yemaya worked as a certified student attorney and student director in the law school's Immigration and Human Rights Clinic. During her two years in the Clinic, Yemaya worked diligently for several clients and successfully secured asylum for a Guinean woman who faced persecution in her home country for her religious beliefs, women's rights advocacy, and public health work during the Ebola crisis. Yemaya and her clinic team worked with this client from start to finish by conducting countless client interviews, compiling her asylum application, connecting her with community resources, drafting the supporting brief, and accompanying the client to her final asylum interview. During her 1L

year, Yemaya traveled to the Texas-Mexico border and provided pro bono representation to immigrants who were subject to the Migrant Protection Protocols. Through this experience, Yemaya represented two young children in a hearing before an immigration judge. Yemaya also demonstrated her commitment to pro bono work during her time as a summer associate with Maslon LLP, by assisting with both a pro bono criminal case and an asylum immigration case.

In addition to providing free legal services directly to clients, Yemaya also has a passion for creating a more diverse future for the legal profession. Through volunteer and mentorship experiences, Yemaya continues to dedicate time to working directly with young middle school-aged students from backgrounds that are historically underrepresented in the legal profession. Through the Maslon firm's UPLIFT Legal Institute for Teens, Yemaya served as a volunteer mock trial coach for 8th graders. The UPLIFT program exposes young students to the legal profession through a year-long mock trial program which teaches them trial skills and connects them with professional role models. Similarly, during her 1L year, Yemaya volunteered with the Minnesota Justice Foundation's own Street Law Program. Through this program, Yemaya and several of her law school colleagues created weekly lessons for 8th grade students in the Minnesota AVID college readiness program. The lessons helped young students understand their legal rights, fostered conversations about the legal profession, and provided an environment where they could ask law students about the steps necessary to become attorneys. Additionally, during the 2020 election year, Yemaya and several law school colleagues created the MJF Voting Project which recruited law students to teach middle and high school students the importance of voting and civic engagement.

#### **Ashley Meeder**

Ashley Meeder came to law school with a background in teaching, nonprofit operations, and advocacy for immigrant communities. During her first year of law school, she volunteered with the University of Minnesota's Asylum Law Project and MJF's Street Law program. She joined Mid-Minnesota Legal Aid's Housing Unit as an MJF Fellow for her first summer and stayed on as a volunteer law clerk during her second year. In her work with MMLA, Ashley directly represented clients in eviction proceedings and housing cases involving severe repair problems.

During her second and third years of law school, Ashley was a student instructor for her school's Legal Research & Writing program, a managing

editor on the Minnesota Law Review, a student director with the Binger Center for New Americans' Federal Immigration Litigation Clinic (FILC), and an intern with the Advocates for Human Rights.

In her time with FILC, Ashley represented clients before administrative agencies, federal district courts, and the US Court of Appeals for the Sixth and Eighth Circuits. Together, Ashley and her FILC teammates helped noncitizens secure release from unconstitutionally prolonged detention, petition for appellate review of immigration removal orders, and seek humanitarian relief from removal.

Ashley spent two semesters with the Advocates for Human Rights as a Research, Education, and Advocacy Intern. In this role, she expanded her research and advocacy on immigration detention issues and reviewed proposed federal immigration policies. She also researched the historical roots of collateral consequences of interactions with the criminal legal system and analyzed their present-day racially disparate effects on access to safe and affordable housing.

Ashley is presently the 2022 Polikoff-Gautreaux Fellow at BPI, a Chicago-based law and policy center that fights structural racism and systemic oppression in Illinois. In her work with BPI, Ashley will continue to confront issues that unfairly burden marginalized communities.

#### Sophia Nocera

Sophia Nocera was nominated by her supervising attorney at the 10th Judicial District Public Defender's office (Wright County). Sophia guided their office through the creation and implementation of a virtual training program for law students. That program allowed their office to continue working with law clerks during the pandemic. Additionally, she led the agency in training and recruitment for this program, which is a vital part of the office's representation team. Other accomplishments include serving as co-counsel in a challenging jury trial. She was praised by the State and bench (as well as their agency) for her commitment and professional performance under difficult circumstances and she was outstanding in representing the Public Defender's office.

Sophia graduated from the University of Minnesota Law School in 2022. She served as an Advisory Board member for the Student Conflict Resolution Center. She graduated with a Bachelor's degree in Journalism and Psychology from the University of Nebraska-Lincoln in 2019.






